

Auxin S4 – Solar System Sizing Spreadsheet Standard Agreement

The following agreement details the services provided by Anamise Pty Ltd to the following user who has downloaded the AuxinS4.zip file from the Anamise Pty Ltd website. The user downloading the file must provide consideration to Anamise Pty Ltd as specified.

1) Acceptance of Services

- a) Anamise Pty Ltd agrees to provide you with a copy of the Auxin S4 Microsoft Excel spreadsheet and Auxin S4 Microsoft Word document.

2) Copyright

- a) The Auxin S4 files are protected by Australian copyright law.
- b) The copyright belongs to Anamise Pty Ltd.
- c) Files may only be changed, modified or shared under circumstances specified in this document.

3) Professional Indemnity

- a) The user of Auxin S4 is responsible for any engineering or investment decisions taken after using Auxin S4 Microsoft Excel spreadsheet and Auxin S4 Microsoft Word document.
- b) Auxin S4 is intended as a guide only.
- c) It is the user's responsibility to acknowledge the method in calculating the results.
- d) The method for calculating results may be obtained by studying the Auxin S4 Microsoft Excel spreadsheet and Auxin S4 Microsoft Word document.
- e) No information calculated by the Auxin S4 Microsoft Excel spreadsheet and Auxin S4 Microsoft Word document is a guarantee of any savings or costs referred to in the report.

4) Viruses and Third-Party Property Damage

8) Consideration

- b) You agree to remain a member of the email marketing list for the length of time that you continue to use any part of the Auxin S4 files.
- c) You agree to meet with an employee of Anamise Pty Ltd for at least 5 minutes per month to hear about other products being offered by Anamise for the length of time that you continue to use any part of the Auxin S4 files. The meeting may be face to face at your office location or over the telephone as decided by an Anamise employee.
- d) You agree to only share or distribute Auxin S4 files, whether modified, rebranded or in original form, with other users who have also accepted this agreement.
